### **VIII. New Business:**

- Bylaw Changes
  - Article 1 Section 1: Membership meetings: 7:00PM on the second Tuesday – Change to: **6:00 PM on the first Tuesday of the month, prior to the Board of Directors meeting (following at 7:00 PM).**
    - 4 No and 24 Yes **APPROVED**
- Article 1 Section 4: At all membership meetings a total of twenty-five (25) members or twenty-five percent (**whichever is less**) of the membership, in good standing of the organization, shall constitute a quorum for all the purposes of such meetings.
  - 0 No and 28 Yes **APPROVED**
- Article 3 Section 1: CURRENT: Dues will be charged on an annual basis for new members from the date he or she joins and will expire on the fifteenth day of the month in which each member's membership expires. A delinquent or suspended member is not entitled to voice or vote in the affairs of S.N.O.R.E., Ltd.
  - Change to: **Membership period is January 1<sup>st</sup> through December 31<sup>st</sup> of each calendar year, regardless of the date of the membership is paid. There is no prorating of membership dues. A delinquent or suspended member is not entitled to voice or vote in the affairs of S.N.O.R.E., Ltd.**
    - 0 No and 28 Yes **APPROVED**
- Article 8 Section 1: CURRENT: The membership must be notified in writing via U.S. mail and electronic mail at least twenty-one (21) days in advanced stating that the nature of all changed and amendments and reason for same.
  - Change to: **The membership must be notified by either U.S. mail or e-mail at least ten (10) days in advance stating that the nature of all changes and amendments and reason for same.**
    - 4 No and 24 Yes **APPROVED**
